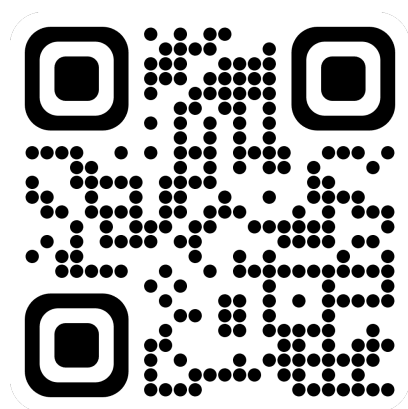

Hon. Tanya R. Kennedy was appointed in July 2020 as an Associate Justice of the Appellate Division, First Department by Governor Andrew M. Cuomo. Prior to her appointment, Justice Kennedy served as a Justice of the Supreme Court, New York County, commencing in January 2016, after election in November 2015. She was elected to Civil Court in November 2005 and thereafter served in Criminal Court, Civil Court, Family Court, as Acting Supreme Court Justice, and as Supervising Judge of Civil Court, New York County.
